#### Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; **Compensatory Arrangements of Certain Officers.**

On September 23, 2022, Consumer Portfolio Services, Inc. (the "Company") announced that it has appointed Denesh "Danny" Bharwani as its Chief Financial Officer and Senior Vice President - Finance. Mr. Bharwani, 54, has been the Company's Senior Vice President - Finance since April 2016.
