Item 8.01. Other Events.

On July 11, 2023, HP Inc. (the "Company") issued a press release announcing the early tender results of its previously announced cash tender offer (the "Tender Offer") for up to a maximum combined aggregate purchase price of \$1.0 billion, including all early tender premiums but excluding accrued and unpaid interest, of its outstanding 3.400% Notes due June 17, 2030, 4.200% Notes due April 15, 2032, 1.450% Notes due June 17, 2026, 3.000% Notes due June 17, 2027, 4.000% Notes due April 15, 2029, 2.200% Notes due June 17, 2025 and 4.750% Notes due January 15, 2028 (collectively, the "Notes"). The Company further announced that it is increasing the maximum aggregate purchase price of the Notes. A copy of the news release announcing the early tender results and the upsizing of the maximum aggregate purchase price, and which describes the Tender Offer in greater detail, is hereby incorporated by reference and attached hereto as Exhibit 99.1.

On July 11, 2023, the Company also issued a press release announcing the pricing for the Tender Offer. A copy of the news release announcing pricing for the Tender Offer is hereby incorporated by reference and attached hereto as Exhibit 99.2.

This Current Report on Form 8-K, including the press releases hereby incorporated by reference, is neither an offer to sell nor a solicitation of offers to buy any of the Notes. The Tender Offer is not being made to holders of Notes in any jurisdiction in which the making or acceptance thereof would not be in compliance with the securities, blue sky or other laws of such jurisdiction.
