The 2023 Annual Meeting of Stockholders of The Boston Beer Company, Inc. will be held at 3:00pm ET on Wednesday, May 17, 2023 at Samuel Adams Boston Tap Room, 60 State Street, Boston, MA 02109.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

THE Board of Directors recommend a vote FOR all nominees listed and FOR Proposal 2 and for 1 YEAR on Proposal 3:

The Class A Stockholders will meet for the following purposes:

- 1. For the election of the three (3) nominees for Class A Director named in the Proxy Statement, to be decided by plurality vote of the holders of Class A Common Stock present in person or represented by proxy.
