On November 14, 2023, the Company closed on the sale of the 221-room Hotel Zoe Fisherman's Wharf, located in San Francisco, CA, for \$68.5 million to a third party. Proceeds from the sale will be used for general corporate purposes, which may include reducing the Company's outstanding debt and repurchasing the Company's common and preferred shares.
