On December 15, 2023, Pebblebrook Hotel Trust (the "Company") issued a press release announcing that its Board of Trustees (the "Board") has authorized, and the Company has declared, cash dividends per share of its common and preferred shares of beneficial interest.

Item 8.01. Other Events.

On December 15, 2023, the Board declared a dividend of \$0.01 per share on the Company's common shares of beneficial interest, \$0.01 par value per share ("Common Shares"), for the quarter ending December 31, 2023 (the "Common Dividend").

On December 15, 2023, the Board also declared a quarterly dividend of \$0.39844 per share on the Company's 6.375% Series E Cumulative Redeemable Preferred Shares of Beneficial Interest, \$0.01 par value per share ("Series E Preferred Shares"), for the quarter ending December 31, 2023 (the "Series E Preferred Dividend").

On December 15, 2023, the Board also declared a quarterly dividend of \$0.39375 per share on the Company's 6.30% Series F Cumulative Redeemable Preferred Shares of Beneficial Interest, \$0.01 par value per share ("Series F Preferred Shares"), for the quarter ending December 31, 2023 (the "Series F Preferred Dividend").

On December 15, 2023, the Board also declared a quarterly dividend of \$0.39844 per share on the Company's 6.375% Series G Cumulative Redeemable Preferred Shares of Beneficial Interest, \$0.01 par value per share ("Series G Preferred Shares"), for the quarter ending December 31, 2023 (the "Series G Preferred Dividend").

On December 15, 2023, the Board also declared a quarterly dividend of \$0.35625 per share on the Company's 5.70% Series H Cumulative Redeemable Preferred Shares of Beneficial Interest, \$0.01 par value per share ("Series H Preferred Shares"), for the quarter ending December 31, 2023 (the "Series H Preferred Dividend").

The Common Dividend is payable on January 16, 2024 to holders of record of Common Shares as of the close of business on December 29, 2023 (the "Record Date").

The Series E Preferred Dividend is payable on January 16, 2024 to holders of record of Series E Preferred Shares as of the Record Date. The Series E Preferred Dividend represents a rate of 6.375% per annum of the \$25 per share liquidation preference (equivalent to \$1.59375 per annum per share).

The Series F Preferred Dividend is payable on January 16, 2024 to holders of record of Series F Preferred Shares as of the Record Date. The Series F Preferred Dividend represents a rate of 6.30% per annum of the \$25 per share liquidation preference (equivalent to \$1.575 per annum per share).

The Series G Preferred Dividend is payable on January 16, 2024 to holders of record of Series G Preferred Shares as of the Record Date. The Series G Preferred Dividend represents a rate of 6.375% per annum of the \$25 per share liquidation preference (equivalent to \$1.59375 per annum per share).

The Series H Preferred Dividend is payable on January 16, 2024 to holders of record of Series H Preferred Shares as of the Record Date. The Series H Preferred Dividend represents a rate of 5.70% per annum of the \$25 per share liquidation preference (equivalent to \$1.425 per annum per share).
